making twenty, which, added to the 182 cast for Blaine, aggregate 203, a clear majority. It is indisputable that General Harrison can carry Indiana, and that General Hawley is sure of Connecticut. Death of Roscoe Conkling.

Roscoe Conkling, who for nine days had been lying at the point of death at the Hoffman House, New York, died Wednesday morning at 1.50.

The deceased was born at Albany, N. Y., October 30, 1829, and was therefore less than 59 years old when he died. His father was an eminent lawyer, was a member of Congress and for many years a United States judge.

Roscoe Conkling began his public career as mayor of Utica, N. Y., was elected to Congress when he was 29 years old, and remained in public life until he resigned his seat in the United States Senate in 1881, because the Senate confirmed his enemy, W. H. Robertson, collector of the port of New York. Conkling believed he would be vindicated by a re-election, but he was defeated and forced to retire from public life. He at once began the practice of law, and soon achieved wonderful success.

He was a man of more than ordinary ability and as an orator had few equals. He had a splendid command of language and his mind was always well stored with ideas. He believed that he was far above ordinary men, and this made him arrogant, overbearing, and even vain.

He could not brook opposition, and he was unfortunate in his quarrels. He always characterized his opponents in terms which conveyed oft rebade rec-

man township, April 12, 1888, Eliza Ellen, wife of Benjamin F. Mattingly, aged 31 years, 8 months and 25 days.

Eliza Ellen Cook was born in Peru, Ind., but came to Plymouth when a child. Her mother dying she was adopted by Mr. and Mrs. David Reynolds and was always known as Ella Reynolds. She married B. F. Mattingly Dec. 25, 1876, was the mother of five children, two of whom are living—a girl nine years and a boy five years old. She died of lung fever after an illness of eight days. She was a member of the Wesleyan church and was a good wife and mother. Her funeral was preached by Rev. H. Longbrake and the remains laid to rest in the Night-hart cemetery in the presence of a large number of neighbors and friends, who hope that she has found a better home in a fairer world beyond the torab. Besides her husband and children and adopted parents she leaves one brother, James Cook, in this city.

HANES—At her home south-east of Argos, Sunday, April 15, 1888, Mrs. Betsey Hanes, aged 77 years, 10 mo. and 7 days.

Her death was caused by hemorrhage of the lungs. The deceased was born near Elizabeth, N. Y., came to Indiana with her husband in 1853, where she has since resided. She survived her husband 20 years; was the mother of nine children, four of whom are still living, with nineteen grand-children nineteen great-grand-children, and many friends to mourn their loss. She was a loving mother and a faithful christian. She united with the German Baptist church in 1878.

Her funeral services were conducted at the Christian church, at Argos, by the Rev. H. Deardorff, and the remains interred at the Argos cemetery, Tuesday, April 17th.

The 8th of May was characterized by severe storms extending across the country from east to west. Many buildings were blown down, and a great many lives lost. It was especially severe in the region of New York. In the extreme West it was also remarkably severe. At Denver, Colorado, hail stones as large as plums fell in the streets to the depth of eight inches.

The Vanderbilt party, while recently traveling over the Canada Southern, made the fastest time on record. The run from Essex to St. Thomas, a distance of ninety-six miles, was made in as many minutes, including two stoppages. Charles V. Hanes.

Charles Vahn Hanes was born in Erie county, Pennsylvania, May 21, 1850, moving to Ohio when one year old. He remained there until he was twenty-one years of age. He then decided to move to Indiana, coming to Plymouth, Oct. 2, 1853.

He lived in Plymouth until March 30, 1855. He was united in marriage to Miss Pelena Ervin, to which union were born 6 children, 1 dying in infancy. The other five lived to be grown. Of these Charley H. passed away July 4, 1919 at the age of 58 years, 7 months and 13 days. There remain to mourn his departure the following children: Hannah Hershberger of Plymouth, Ind.; Bettie M. Sheets of Morris Ill.; Jas. S. Hanes of St. Joseph, Mo.; Alma Johnson of Conneaut, Ohio.

Mr. Hanes had an attack of nervous breakdown of which he never recovered and passed away at 5:00 a. m., July 17, 1920, at the age of 90 years, 1 month, 26 days. On May 10, 1920, he united with the Brethren church and passed away in the full faith in the Lord. Funeral was conducted by Rev. Hostettler at the Walnut church, southeast of Argos on Monday, July 19 at 2:00 p.m. with burial in the cemetery nearby.
